# 60/24 HIGHWAYS ISSUES

- a) Update about highway issues: All below.
- b) Footpath down Pounce Hill: The Clerk will check that the path is on the cutting schedule with ECC. Clerk to ask Tom Cunningham about rearranging the site meeting at Pounce Hill footpath that was cancelled by ECC. Some of the residents of Sewards End are cut off, from walking into Saffron Walden as they cannot push a pushchair or ride a mobility scooter down the path and it is dangerous to try to use the path.
- c) Accident down Pounce Hill and report to Highways: Tom Cunningham (Highways) has informed the PC that following a survey of the road on 29<sup>th</sup> February the defects were recognised, but they weren't classed as urgent works, but in the light of the accident the carriageway repairs are being assessed by Essex Highways and a job will be raised to resolve the issues identified. The location has also been added to the jetting schedule, which will require a road closure which will take 12-14 weeks to arrange.

The Clerk will ask Tom Cunningham for a copy of the survey from 29<sup>th</sup> February.

Clerk to ask Bob Barnes if a letter was sent to Kemi Badenoch.

- a) Tractor and trailer installation: The tractor and trailer was installed today. The installers spent more time taking out the old safety matting and they have agreed a  $\pounds$  500.00 credit off the final invoice. Kelvin Newman will put in additional soil and turf around the end of the equipment as soon as possible.

- c) Entrance to the Village Green: Tim Wells has offered to drain the entrance and the Clerk will ask about the possibility about laying a path.
- **d) Phase 2 of the play area improvements:** The surfacing underneath the tables to be investigated and further improvements. Further improvements to be discussed.
- **e) Village Triangle:** The PC will ask Kelvin Newman to cut the village triangle more regularly. The PC also discussed putting two planted tubs or a small tree in the middle of the triangle. The wooden posts are to be recemented in, Adrian Knowles to assess.
